

Early Childhood Education Checklist

The University of Pittsburgh, School of Education, offers an Early Childhood Education Program to prepare students to teach young children (birth to age 8) and to work collaboratively with their families and other professionals. Students will develop skills for employment in public and private schools and centers, homes, and other facilities in which children within this age range and their families are served. Through coursework and field experiences with infants, toddlers, preschoolers, and primary-aged children, students acquire competence in the use of developmentally appropriate practices. Special emphasis is placed on understanding and respecting family diversity, supporting families in their roles with young children, and supporting children with special needs in inclusive settings. The program is designed for full-time study, but may be adapted for part-time study. Details are outlined below.

To be considered for admission, applicants need to have:

- submitted a completed [School of Education application](#) form and the application fee
- earned an undergraduate degree with a minimum QPA of 3.0 (applications from students who plan to earn their undergraduate degree before the term of admission will be considered)
- submitted official transcripts from all institutions attended
- submitted a copy of the spring registration form if enrolled in spring term courses
- completed the appropriate number of prerequisite credit hours in [Academic Prerequisites](#)
- completed the appropriate number of prerequisite credit hours in [Chapter 354.23 Prerequisites](#)
- completed the appropriate number of prerequisite credit hours in [Education Prerequisites](#)
- submitted evidence of passing scores on the PRAXIS I test series (reading, writing, and mathematics)
- submitted three letters of academic and/or professional recommendation
- submitted a thoughtful, clearly written goal statement of two to three double-spaced typewritten pages
- submitted a resumé

MEETING OR EXCEEDING THE APPLICATION CRITERIA DOES NOT GUARANTEE ADMISSION

The Early Childhood Certification Program is intended for individuals from a wide-range of undergraduate backgrounds including, Communication Science and Disorders, Psychology, Child Care/Child Development, Law, Business, Social Work or other related fields of study, who wish to pursue careers as Early Childhood Educators.

The program follows the personnel recommendations established by the Association for Teacher Educators (ATE), the National Association for the Education of Young Children (NAEYC), and the Division for Early Childhood of the Council for Exceptional Children (DEC).

A student who successfully completes the program, including the PRAXIS I and II Exams, and the PA Statewide Evaluation Form for Student Professional Knowledge and Practice (PDE 430) is eligible to apply for a Pennsylvania Instructional I Certificate for Nursery School – Grade 3.

The Certification Program in Early Childhood Education - Professional Year (PY) Program

- prepares qualified liberal arts and science graduates for initial certification in Early Childhood Education
- lasts two consecutive terms for full-time students – fall and spring (late August – late April)
- consists primarily of evening courses
- for full-time students, requires four full days per week at practicum and Pre-Kindergarten student teaching sites in Fall term and five days a week in a primary-aged classroom (Kindergarten-Grade 3) in the Spring term.

Chapter 354.23 Prerequisites

Section 354.23 of the Pennsylvania Department of Education teacher certification requirements states that all prospective candidates must take at least 6 semester hour credits in college level English and 6 semester hour credits in Mathematics with a grade of C or better.

Education Prerequisites (15 credits)

Education prerequisites must be taken prior to the fall term of the PY program.

The following approved clearances are required before taking Introduction to Early Childhood Education and Foundations of Special Education: Federal Criminal History Record, Act 34 – PA State Police Criminal Record Check, and Act 33/151 PA Child Abuse History.
